Vibrant 988 Lifeline Network Agreement rollout timeline:

- **June 22:** Review period ends.
- **July 1:** Network Agreement is sent for signature.
- **July 31:** Network Agreement is returned for signature.
- **August 1:** Compliance period begins.
- **October 31:** Compliance period ends.
- **November 1:** Network Agreement goes into effect.
